Engineer stated:

- ~The Planning Board must approve the application/site plan before the Department of Transportation will approve.
- ~Engineer states he does not feel traffic flow will increase a significant amount.

Report from DOT: Average counts {based on survey done on October 2011}

Average Daily Traffic: 2479

AM Peak: 171 PM Peak: 234

Current Daily Customer Count for Dexter Market: 550: AM Peak-120: PM Peak: 190

- ~Site distance more than efficient.
- ~Gas delivery will probably be once a week/possibly twice a week during summer months.

Jean Simoneau will fill out Part Two of the SEQR Impact Statement. Discussion on question 5. {Adverse change in existing level of traffic}

- ~Present store traffic is congested and vehicles are backing out into traffic. New store location, vehicles will not be backing into traffic.
- ~Majority of traffic for new market will be on Route 180, alleviating traffic on East Kirby Street. Route 180 is more capable of handling the traffic.
- ~More parking spaces will be available at new location.
- ~Parallel parking allowed on Route 180.
- ~Traffic flow will be improved.
- ~No way to align entrance/exit driveway with Lakeview Drive.
- ~Question of traffic causing a bottleneck if vehicles are turning left into market/gas station.

Members feel there is a possibility for a moderate to large impact on the existing level of traffic.

Proposed sign falls within our law. Sign on building will be a maximum of 2 foot x 6 foot. Free standing sign will be double sided and a maximum of 5 ft. x 7 ft. and 24 ft high.
